

Terms of Use

Introduction

These terms of use govern your use of maypoleeducation.com and any other of our sites (collectively, the “Site”), any Maypole games downloaded from one or other Site (the “Games”), and all of the services made available on the Site (the “Services”). By using the Games, Services or visiting or browsing the Site, you acknowledge that you have read, understood, and agreed to be bound by these Terms of Use and any changes that may be made to these Terms of Use from time to time.
